Nomination Check List

Complete checklist before returning nomination materials

- Read Nomination Rules and Guidelines. Market steers, commercial heifers, barrows, gilts, wether lambs, commercial ewes, wether goats & doe goats must submit a nomination.
- DNA kits must be ordered by June 20. DNA kits include DNA envelope and Tulsa tag.
- Be sure the EID button and Visual Tag are matched together when tagging animals.
- Make sure you tag the animal(s) with a tag assigned to that specie:
 - Cattle Tags are PINK
 - Goat & Sheep Tags are BLUE
 - Swine Tags are YELLOW
- Submit exhibitor and animal information online **by 5pm on July 1** at, <https://tulsa.fairmanager.com>.
 - Every animal you nominate must have nomination information submitted online.
 - If family nominating, each animal must be nominated online in each siblings name.
 - Mail a copy of exhibitor(s) online receipt with the DNA sample.
- Make sure DNA hair envelope includes the following:
 - 40 hairs with follicles intact
 - Completely sealed envelope
 - Correct Tulsa Tag Number corresponding with the DNA sample in the envelope
 - Signature of **all possible exhibitors**, parent, CEA or FFA Instructor, and collector
- In order to properly family nominate, enter each exhibitor online and list every animal in each exhibitor's name. All exhibitors must sign the DNA sample envelope.
 - Only one DNA envelope per animal is required.
 - All exhibitors' names and signatures must be on the DNA envelope.
 - You should have an online receipt for each sibling showing the animal nominated.
 - The primary exhibitor will not be chosen at nomination time. The final exhibitor decision will be made at the time of entry.
- All possible exhibitors must sign ALL hair sample envelopes.**
- Attach online nomination receipt to corresponding hair envelopes. (Do not Staple)
- Additional requirements for steer exhibitors: (*Crossbred steers do not need to complete additional steps.*)
 - Upload a completely filled out breeders certificate online with nomination.
 - Upload three photos of the steer online: front view, right, and left side profile.
- Exhibitors should maintain a copy of the nomination receipt.
- Mail nominations postmarked by July 1 to: TSF Livestock Office, 4145 E 21st Street, Tulsa, OK 74114
- Commercial Heifers must order DNA kits by July 20 and submit online nomination by August 1.
 - Commercial Heifers cannot be family nominated.
 - Commercial Heifer DNA samples must be postmarked and mailed by August 1.
- Nominations will be processed and posted on the Tulsa State Fair website. Review all of your nominations and inform the Livestock Office of any corrections that need to be made.
